### **Appointments within Omnes Capital: Omnes Capital has promoted two Principals and three Associates and is welcoming one new Associate, a Director of Operations and a new Head of Human Resources.**

#### Buyout & Growth Capital – Mid Cap

**Ludovic Valentin-Pereira** is appointed Principal within the Mid Cap Buyout & Growth Capital team, reporting to **Éric Rey**, Managing Partner.

The Mid Cap team invests in SMEs with high growth potential via Omnes Croissance 4. This fourth generation fund (€210m) has invested in Cogepart (express delivery service), Bimedia (software solutions for local retailers), Dispam (temperature-controlled transport), Circet (telecoms infrastructure) and ANI (distributor of fasteners for the aerospace sector). It sold Capcom (fibre optics and cable network installation) in February 2017.
